SLAVERY & TERRITORIES	1856 - Declared "NON-INTERFERENCE BY CONGRESS WITH SLAVERY IN STATE AND TERRITORY, OR IN THE DISTRICT OF COLUMBIA." Supported faithful execution of the Fugitive Slave Law. 1860 - Reaffirmed the 1856 platform and said the party would abide by Supreme Court decisions on slavery in the territories. A Southern/Breckinridge faction adopted stronger federal protection for slave property.	1856 - Invoked the principle that "all men are endowed with the inalienable right to life, liberty, and the pursuit of happiness" and opposed establishing slavery in U.S. territories by positive legislation. 1860 - Declared: "That the normal condition of all the territory of the United States is that of freedom," and denied authority to give slavery legal existence in a U.S. territory.	The Democratic Party split in 1860; the reverse identifies the convention platform and Breckinridge faction separately.
RIGHT TO LIFE (ABORTION)	1992 - "Democrats stand behind the right of every woman to choose, consistent with Roe v. Wade, regardless of ability to pay." 1996 - Repeats the Roe / ability-to-pay position. 2000 - Again states the right to choose consistent with Roe, regardless of ability to pay. 2004 - Stands for a woman's right to choose consistent with Roe and regardless of ability to pay. 2024 - Pledges national legislation to restore Roe protections and repeal the Hyde Amendment.	1992 - "the unborn child has a fundamental individual right to life which cannot be infringed." 1996 - Repeats that fundamental-right-to-life language and opposes public revenues for abortion. 2000 - Again states the unborn child's fundamental individual right to life. 2004 - Repeats that language and opposition to public revenues for abortion. 2024 - Says states are free to pass laws protecting life; opposes late-term abortion while supporting prenatal care, birth control and IVF.	Continuity through 2004 is followed by a materially different post-Dobbs Republican formulation in 2024.
MARRIAGE & FAMILY	1992 - Supported civil-rights protection for gay men and lesbians and ending discrimination based on sexual orientation. 1996 - Supported further inclusion of gay men and lesbians in national life. 2000 - Supported full inclusion of gay and lesbian families and equitable alignment of benefits. 2004 - Supported full inclusion and equal responsibilities, benefits and protections; said marriage historically was defined at state level. 2024 - Defends LGBTQI+ rights and cites the Respect for Marriage Act.	1992 - Spoke of traditional family values and judges respecting them. 1996 - Endorsed the Defense of Marriage Act. 2000 - Supported the traditional definition of marriage as the legal union of one man and one woman. 2004 - Sought to preserve legal recognition and benefits for the union of one man and one woman. 2024 - Promotes a culture valuing the "Sanctity of Marriage" and the foundational role of families.	Year-specific wording is used because the parties' formulations changed materially over time.
RIGHT TO BEAR ARMS	1992 - Supported a reasonable waiting period/background check for handgun purchasers and restrictions on assault weapons. 2000 - Called for stronger gun laws, child-safety locks, and a photo ID, full background check and gun-safety test for a new handgun. 2024 - Calls for universal background checks, safe-storage requirements, a national red-flag law, and bans on assault weapons and high-capacity magazines.	1992 - "Republicans defend the constitutional right to keep and bear arms." 1996 - Defended that constitutional right while supporting an instant check for convicted felons. 2000 - Defended the right while supporting criminal background checks and opposing federal licensing and national registration. 2024 - Lists "the right to keep and bear arms" among fundamental freedoms.	The website source archive provides fuller context behind shortened print excerpts.
TAXES & GOVERNMENT	1996 - Described the party as committed to targeted tax cuts. 2000 - Sought specifically targeted tax cuts. 2004 - Proposed rolling back Bush tax cuts for those making more than \$200,000. 2024 - Proposes raising the corporate tax rate from 21% to 28%, alongside other changes affecting corporations and high earners.	1996 - Supported an across-the-board 15% cut to marginal tax rates. 2000 - Called for a simpler, flatter and fairer tax system with broad tax cuts. 2024 - Calls for large tax cuts, including no tax on tips, and continuation of Trump-era tax policy.	The 28% corporate-rate proposal is a 2024 Democratic platform position.
